School premises shall not be used for commercial purpose and anti-National activities. 11.

Approval of Managing Committee shall be obtained from the appropriate authority in case of any change 12. in the committee.

The Managing Committee shall follow the instructions issued by Government/Director from time to time 13. and supply the information to the Govt./ Department as required.

In addition to above the Managing Committee shall abide by the provisions of Heryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary 14. action in case of violation of any provisions of the rules.

School will provide ramp within six months. 15.
